5. Parks close at 9 PM without special written permission from the Arlington Recreation Department.
6. Vendors are not allowed in park areas, including parking lots.
7. The following are prohibited: Alcohol, Littering, Cookouts, Golf.
8. Dogs must be leashed as per bylaw article 12, section 10 and clean up per bylaw, article 12, section 10a.
9. Use of amplification of any kind must receive approval from the Park Commission and/or the Recreation Director.
